

## Animal Clinic Dog Social Hour Waiver

I (the "Owner") hereby represent that I am the legal owner of the dog \_\_\_\_\_ (the "Dog") to participate in Animal Clinic Social Hour

I, the undersigned, am satisfied that Animal Clinic facilities are maintained for the health, comfort, and protection of my animal(s).

I understand and agree that in admitting my dog(s), Animal Clinic has relied upon my representation that my dog(s) is/are in good health.

I understand that my dog may have harmed or shown aggressive or threatening behavior towards any person, or any other dog and that said dog will remain on leash until Animal Clinic staff deems said dog has graduated to off leash play and interaction.

I hereby release Animal Clinic employees, assistants, and staff from any and all liability, claims, suits, actions, loss, injury or damage of any nature or kind, which I, the Dog and any third party or their pet may suffer, including specifically, but not without limitation, any accidents, injury, damage, loss or death of my animal at the premises of 2905 West Hwy 6 Hastings, NE 68901 while in attendance and participation at Animal Clinic Social Hour

I agree that I am responsible for any medical and legal responsibility of my pets' actions. I approve Veterinary care for my dog while participating in Animal Clinic Social Hour.

I understand that although all dogs are fully supervised and I am in attendance, that incidents of injuries may occur. This includes that my dog could receive bites, scrapes, and scratches from his/her playmates. I understand I am solely responsible for any harm caused by my Dog to another dog while they are at Animal Clinic Social Hour.

I represent that my dog is in good health, is current on all required vaccinations, is current and has not been ill with any known contagious diseases. Required vaccinations are:

### **Rabies, Dhpp, Bordetella**

I understand that Flea/Tick medication is recommended but not mandatory and understand that these may be contagious amongst groups of dogs.

I understand that while my dog is fully vaccinated that vaccines are not 100% fool proof and there is still a risk (albeit minimal) that my dog may contract a contagious virus/disease. I understand that should this occur, I agree to allow 7 days waiting period after my dog has had his/her vaccinations to allow the vaccines to reach full protection potential and to ensure my dog has not had any negative reaction to the vaccines.

Should I allow my dog to participate in Animal Clinic Social Hour in a shorter than 7 days wait period from day of vaccinations, I understand that my dog could be at risk of contracting a contagious virus/disease.

I understand that if my dog is over the age of 7 months, they must be spayed/neutered to participate in Animal Clinic Social Hour.

I agree to disclose any previous or current medical issues/concerns of my dog so that Animal Clinic staff can decide of suitability for Social Hour.

I understand that the Animal Clinic Social Hour is on Tuesdays from 5pm – 6pm. I understand that I may come and go at any time between 5pm and 6pm on Tuesdays while Animal Clinic staff is here.

I understand that Animal Clinic Social Hours is just that, Social Hour. It is not daycare or boarding, nor is it daycare or boarding pickup and drop off.

I understand that I must be in full attendance for Animal Clinic Social Hour and can at no point leave while my dog is still here.

I understand that I am to walk my Dog in and out of the facility on a leash, and in a safe and expedient manner.

I understand that Social Hour may be cancelled due to weather, or personal reasons of the staff in attendance at any time. I understand to check all Animal Clinic social media platforms for updates on cancelations or changes.

I agree that Animal Clinic is not responsible for any lost or stolen items that accompany my dog during daycare. I.e. Jackets, booties, collars and leashes.

I understand that to maintain control and exhibit leadership in a large group of un-kenned dogs certain humane training and disciplinary methods may be used as the owners or staff of Animal Clinic see fit given the circumstances.

I agree that the Dog may be videotaped, photographed, and/or recorded. Animal Clinic shall be the exclusive owner to the results and all proceeds of such taping, photography, and recording.

I certify that I have read and understand the rules and regulations herein and that I have read and understand this agreement.

I agree to abide by the rules and regulations and accept all terms, conditions, and statements of this agreement and confirm the truthfulness of the contents of the application form completed by me.

I am of the full age of eighteen years of age.
